Call to Order

The Public Policy Committee of the Texas Council for Developmental Disabilities convened on Thursday, August 4, 2022, at the at the Embassy Suites Austin Central, 5901 North IH 35, Austin, TX 78723 as well as virtually using the Zoom platform. Committee Chair Lora Taylor called the meeting to order at 1:45 PM. A quorum was present.

1. Introductions

Committee members, staff and guests were introduced.

2. Public Comments

Four public comments were offered. Linda Litzinger of Texas Parent to Parent commented on the topic of Electronic Visit Verification.

3. Consideration of Minutes

The Committee reviewed the minutes from the May 5, 2022, Public Policy Committee meeting and no additions or corrections were noted.

4. **Chair's Remarks**

A. Member Absences: Chair Taylor noted that there were no absences.

B. Chair's Quarterly Activities: Taylor discussed her virtual attendance of the Coalition of Texans with Disabilities' Raise Your Voice series, her outreach to a variety of lawmakers, her communication with a news reporter regarding medical cannabis, and her participation in poll watcher training.

5. **Member's Quarterly Activities Report**

Committee members provided updates from the previous quarter regarding involvement in advocacy and other activities.

6. **Presentation: Guardianship**

Chair Taylor introduced Committee member Sean Jackson to provide a presentation on guardianship and alternatives to guardianship. The Committee then discussed the matter further, and Policy Analyst Lauren Gerken provided an update on a report on guardianship policies currently being prepared by the Governor's Committee on People with Disabilities.

7. **TCDD Position Statements**

Chair Taylor asked Committee member Bill Coorsh to provide an overview of the recommendations of the TCDD Position Statements Workgroup, which was comprised of Council members Ronnie Browning, Coorsh, Kyle Cox, and Angie Panzica. Coorsh then led a discussion on the Position Statements, during which additional minor grammatical changes were recommended.
