7. Update on the 88th Texas Legislative Session

TCDD Public Policy Director Scott Daigle provided an update to the Committee on disability-related bills that have been progressing at the legislature this session.

8. State and Federal Policy Update

The TCDD Policy staff provided updates regarding the end of the federal Public Health Emergency on May 11, as well as the White House's recent executive orders to expand access to affordable, high-quality care, and provide support for care workers and family caregivers.

9. Public Input on Committee Discussion

No public input was provided.

10. Future Agenda Items

Committee Member Kyle Cox discussed the monopoly that two companies hold over the motorized wheelchair industry, and the impacts that has on people that utilize the devices.
