#### Call to Order

The Executive Committee of the Texas Council for Developmental Disabilities convened on Tuesday, August 2, 2023, at the Royal Sonesta Houston Galleria, 2222 West Loop South, Houston, TX 77027 as well as virtually using the Zoom platform. Council Chair Mary Durheim called the meeting to order at 1:07 PM. A quorum was present.

#### 1. Introductions

Committee members, staff and guests were introduced.

#### 2. Public Comments

Stefan Cole Board Member of Texas Parent to Parent spoke about services needed in rural communities of Texas.

#### 3. Consideration of Minutes

The Minutes were reviewed, and no additions or corrections were noted.

#### 4. TCDD Quarterly Financial Report

TCDD Finance and Grants Director Rey Valldejuli reviewed the summary of funds for FY 2022 – FY 2023 as well as projections for FY 2024 – FY 2026. Valldejuli reviewed the operating expenses and total grant expenses showing amounts obligated for each year as well as funds available for new grant projects. He also reported the stipend expenditures and individual expenses from current grantees. He noted the new format of these reports that have been generated from the new Quickbase tracking software.

#### 5. FY 2024 Operating Expense Budget

Valldejuli presented a breakdown of the proposed operating budget for fiscal year 2024, encompassing both indirect non-state plan activities and direct state plan activities. He noted that the budget includes provisions for 18 full-time equivalents (FTE), one borrowed FTE, and accounts for a 5% salary increase awarded for state employees during the 88th Texas Legislature. Valldejuli highlighted that the primary changes in the budget are related to the 5% salary increase and projected inflation-related increases in expenses.

Valldejuli noted that many grants have been elevated in risk due to late submissions but emphasize that there are no significant concerns aside from the need for timely paperwork.

## 8. Memorandum of Understanding with Texas Education Agency

Chair Durheim discussed the process for annual review of the Memorandum of Understanding (MOU) with Texas Education Agency. She noted that the MOU has been signed for a 3-year period but that revisions could be recommended if needed. No recommendations were given.
