Call to Order

The Public Policy Committee of the Texas Council for Developmental Disabilities convened on Thursday, August 3, 2023, at the Royal Sonesta Houston Galleria, 2222 West Loop South, Houston TX 77056, as well as virtually using the Zoom platform. Lora Taylor called the meeting to order at 1:31 PM. A quorum was present.

1. Introductions

Committee members, staff and guests were introduced.

2. Public Comments

Public comment was provided by Linda Litzinger of Texas Parent to Parent, who discussed the use of educational representatives when a student with disabilities cannot provide consent for educational decisions. Litzinger also stated that a bill on the matter failed to pass in the Legislature's regular session and mentioned efforts to add the topic to a future special session.

6. Presentation: The Arc of Greater Beaumont

TCDD Public Policy Director Scott Daigle introduced Sarah Hardin, Executive Director of the Arc of Greater Beaumont who provided details on the organization's structure and work. Hardin then introduced three of the organization's peer support specialists – Ashley Sattler, Katie Sheffield, and Lisa Simmons – and the group discussed the Arc of Greater Beaumont's activities during the 88th Texas Legislature's regular session.

7. Legislative Wrap-Up

The Committee discussed the recognition of TCDD Legislative Champions.
