# <u>Call to Order</u>

The Project Development Committee of the Texas Council for Developmental convened on Thursday, November 2, 2023, at the Hilton Houston Post Oak by the Galleria, 2001 Post Oak Blvd., Houston, TX 77056, as well as virtually using the Zoom platform. Gladys Cortez called the meeting to order at 1:35 pm. A quorum was present.

# 1. Introductions

Committee members, staff and guests were introduced.

# 2. Public Comments

No public comments were offered to the Project Development Committee.

# 3. Consideration of Minutes

The minutes were reviewed, and no corrections or additions were noted.

### 4. Chair's Remarks

Gladys Cortez reported the expected absences of Committee Chair Meridith Silcox, Jamie Thomas, and Jonas Schwartz from TWC.

Cortez shared that she is working on a task force in the City of Edinburg including sensitivity training that will be presented to city employees and contractors.

#### 5. Members Quarterly Activities

Committee members shared their updates on their disability-related activities during the previous quarter.

#### 6. Staff Reports

TCDD Finance and Grants Director Rey Valldejuli reported on the new projects that began this quarter, with two ongoing Request for Applications (RFAs) scheduled to conclude on November 17, 2023. Also reported were the five projects that were successfully completed this quarter and that seven projects are currently in their final year. Valldejuli highlighted seven projects slated for continuation in February 2024.

Valldejuli presented a breakdown of factors contributing to risk, including reporting timelines, submission of Requests for Advance or Reimbursement (RARs), project deliverables, timeliness in requesting revisions, the duration of the organization's activity, and other factors outlined in the grant manual. Notably, three projects were identified as having elevated high risks, primarily due to financial issues, either delayed or outstanding RAR submissions. Aside from these instances, no other significant issues were reported regarding the grantees.

## 7. Future Activities for State Plan Implementation

Gladys Cortez discussed the executive summary regarding Addressing Targeted Disparities: Barriers to Employment in South Texas Region. Committee Members recommended the following modifications to the executive summary:

- 1. Clarify which counties in South Texas the executive summary is addressing.
- 2. Refine the outcomes section to include more measurable outcomes and outputs.

**MOTION:** To recommend Council funding of the Addressing Targeted Disparities: Barriers to Employment in South Texas at \$125,000 per year for up to two years with the Committee's revisions.

### 9. Presentation: Community Based Recreational Opportunities

Regional Coordinator Erin Fogarty led a presentation on the importance of recreation opportunities for people with IDD in their communities. Fogarty highlighted potential barriers to recreation for individuals with disabilities, particularly focusing on young adults transitioning out of the school system. Fogarty emphasized the

importance of decreasing barriers ranging from non-involvement due to a lack of suitable programs to historically segregated or adapted recreation opportunities that may not align with individual interests.

#### 10. Future Activities for State Plan Implementation

Gladys Cortez discussed the five projects that ended this quarter and led a discussion on potential future projects.

Executive Director Beth Stalvey discussed ongoing projects in their final year. Stalvey noted the focus is on continuing and sharing the work of these projects, including suggestions for collaboration and the dissemination of findings.

The Committee discussed issues regarding healthcare professionals, patient care for people with I/DD, and ideas about future projects related to education opportunities to bridge the gap between patients with I/DD and healthcare professionals.

### **11. Future Project Funding Priorities**

The Committee evaluated the future Funding Priorities List. Members reviewed the list as provided by staff, removed projects that have been initiated, added the newly recommended project, and revised the order of the projects to conform to the Committee's goals.

**MOTION:** Recommended Council approval of the Future Funding Priorities List as Follows:

- 1. Culturally Competent Family Supports
- 2. TCDD Storytelling Project
- 3. Targeted Disparity: Barriers to Employment in South Texas
- 4. Medical Self-Advocacy
- 5. Prevention and Response to Sexual Offenses: Medical and Therapeutic Professionals
- 6. Prevention and response to Sexual Offenses: Criminal Justice Response to Cases Involving People with IDD
