Rochford presented the website, showed the accessibility features, and answered questions from Council Members and staff.

C. Project Closeout Executive Summary – draft

TCDD Executive Director Beth Stalvey presented a new draft Project Closeout Executive Summary to the Committee that could be used

Stalvey stated that the state plan should be looked at by the Committees each quarter to see what projects are beginning, ending, or which goals and objectives should be focused on at the next meeting.

The Committee evaluated the Future Project Funding Priorities List. Members reviewed the list a provided by staff and made no changes. No vote was needed and no recommendations will be made to the Council.
