# 4. Chair and Executive Director's Report

TCDD Executive Director Beth Stalvey provided updates on two staff vacancies, including the Public Policy Analyst position and the West Texas Regional Coordinator position.

Stalvey reported 12 stipends approved during the last quarter and highlighted activities on leadership, public policy and upcoming events and initiatives, including Mental Health Awareness Month and Older Americans Month. Stalvey reported on the youth ambassador program and its engagement in various projects, including collaboration with Wellpoint on transition to adult medicine. Stalvey discussed the

upcoming Technical Assistance Institute hosted by iTACC and noted that sessions were available for Council member participation.

Director Stalvey provided updates on ongoing projects, such as the Bridging Aging Disability Network grant and the public health workforce expansion project, set to conclude in August.

# 5. Future Activities for State Plan Implementation

#### 1. Choice Making Among Youth Age 0-14: A Foundation for Self-Determined Lives

Project Development Committee Chair Meridith Silcox reported on the Committee discussion of the executive summary for Choice Making Among Youth Age 0-14: A Foundation for Self-Determined Lives. Silcox reported that funding is recommended for one project for up to \$300,000 per year for up to five years and noted the additions to the executive summary given by the Committee.

TCDD Finance and Grants Director Rey Valldejuli reviewed the quarterly financial report, current grantee projects report, and the stipend expenditure report.

Council Business Director Koren Vogel discussed updates to the Conflict-of-Interest report.

### 8. Project Development Committee Report

Project Development Committee Chair Silcox reported that the Committee received a presentation from the Executive Director of the Wisconsin Board for People with Disabilities and the discussion of new potential projects and how they would fit into the State Plan. Silcox also noted that the Committee discussed ideas surrounding generational advocacy and how self-advocacy may look moving forward.

## 9. Public Policy Committee Report

Public Policy Committee Chair Angie Panzica reported on Committee activities. She noted that the Committee received a panel discussion regarding accessible child care followed by discussions of TCDD's legislative efforts on accessible child care.

Panzica further reported on the Committee's discussion on legislative updates from members of staff. Panzica highlighted the Texas Promoting Independence Stakeholders Summit, a group to increase independence for people with disabilities.

# 10. Older Americans Month Highlight: Interdisciplinary Tele enabled Health Homes for Aging Adults with IDD – The University of Texas Health Science Center at Houston

Dr. June Sadowsky discussed her project that focuses on establishing health homes for aging adults with intellectual and developmental disabilities (IDD) in Texas. Sadowsky highlighted major accomplishments, including statewide workshops on intellectual disabilities and dementia, caregiver support networks in rural areas, and partnerships with various stakeholders. Sadowsky's team has identified barriers to healthcare access for aging individuals with IDD and aims to address them through interdisciplinary health homes, training programs, and Project Echo, an online platform facilitating knowledge exchange among healthcare professionals.

Sadowsky reported that with a focus on sustainability, the project aims to establish a statewide network of trained professionals to continue providing support beyond the grant period, ultimately enhancing the quality of life and healthcare outcomes for aging individuals with IDD in Texas.
