Call to Order

The Executive Committee of the Texas Council for Developmental Disabilities convened on Wednesday, May 1, 2024, at the Hyatt Place Houston Medical Center, 7329 Fannin St, Houston, TX 77030 as well as virtually using the Zoom platform. Mary Durheim called the meeting to order at 2:00 P.M. A quorum was present.

1. Introductions

Committee members, staff and guests were introduced.

2. Public Comments

Public comment was provided by Linda Litzinger from Texas Parent to Parent regarding dental appointment availability for people with disabilities.

4. TCDD Quarterly Financial Reports

TCDD Finance and Grants Director Rey Valldejuli reviewed the summary of funds for FY 2023 – FY 2026 highlighting the use of remaining funds from FY 2022 and FY 2023. Valldejuli noted that TCDD has not yet received the full allotment of funds for FY 2024 but anticipates that the funds will be received in the next few months. Valldejuli discussed grants that ended this quarter totaling approximately \$600,000.

Valldejuli discussed the current grantee report and the stipend expenditure report highlighting the stipends that were awarded for FY 2024.

5. Continuation Grant Awards

Chair Durheim read a statement regarding Conflict of Interest prior to the consideration of funding for grant projects, reminding members, staff, and guests to excuse themselves from the conversation if a conflict of interest exists.

Finance and Grants Director Rey Valldejuli presented the executive summary for the Establishing and Inclusive Four-Year Postsecondary Education Program at Texas State University.

6. New Grant Awards

A. Targeted Disparity – Increasing Employment Opportunities for Adult Texas with IDD in South Texas

TCDD Senior Policy Analyst Lauren Gerken presented applications for the Targeted Disparity - Increasing Employment Opportunities for Adult Texans with IDD in South Texas Request for Applications (RFA). A total of two applications were received, and both applications met the criteria for independent peer review panel and staff review. The Council previously approved the funding for one project for up to \$125,000 per year for up to two years. The purpose of this project is to address targeted disparity and barriers to employment for people with DD in South Texas.

The Council previously approved the funding for one project for up to \$300,000 per year for up to five years. The purpose of this project is to provide technical assistance to TCDD state plan sub-grantees on collecting and summarizing both individual and system change stories within their projects.
