Call to Order

The Committee of the Whole of the Texas Council for Developmental Disabilities convened on Thursday, May 8, 2025, at the Westin San Antonio North, 9821 Colonnade Blvd, San Antonio, TX 78230. Council Chair Andrew Crim called the meeting to order at 8:53 A.M. A quorum was present.

1. Introductions

2. Public Comments

3. Update – Texas Legislature

Public Policy Director Scott Daigle discussed the ongoing 89th Texas Legislature and the impact of pending legislation on people with disabilities, including areas of focus in the TCDD Public Policy Priorities.

4. Council Member Development

a. Texas Administrative Code

Executive Director Beth Stalvey discussed the process for periodic review of the Texas Administrative Code. TCDD's administrative code exists in Title 40, Part 21, Chapter 876 General Provisions, and Chapter 877 Grant Awards. During the next few meetings, members will review the rules and may offer revisions or choose to re-adopt without revisions. Notice of opportunity for public comment will be posted in the Texas Register at each stage of review. Members will also review Council Policies and Procedures as part of this process and may choose to revise as needed.

b. TCDD State Plan Development FY 2027 – FY 2031

Executive Director Beth Stalvey discussed the beginning steps for developing the FY 2027 – FY 2031 State Plan Goals and Objectives. Stalvey reviewed the purpose of the State Plan in reporting how funds will be spent and what outcomes are desired for Texas as well as the timelines to develop the plan. Stalvey discussed the steps taken to evaluate the needs of Texans with disabilities and make recommendations for actions based on those needs. Council members provided feedback on their vision for the state at the end of the five-year period and discussed public input and workgroups.
